Gold and silver prices are modestly lower in early-afternoon U.S. trading Wednesday. Both markets are this week seeing normal and healthy corrective pullbacks from recent gains that pushed prices to multi-month highs. A rebound in the U.S. dollar index this week is also a negative for the precious metals markets. April gold futures were last down \$2.90 an ounce at \$1,316.20. March Comex silver was last down \$0.096 at \$15.74 an ounce.

Precious metals traders are looking for a new fundamental spark to ignite their markets. However, with Chinese markets and some other Asian markets closed this week for the Lunar New Year holiday, it's making for some subdued trading in world markets so far this week.
